Know all men by these presents, That Jens Jenson, a widower,

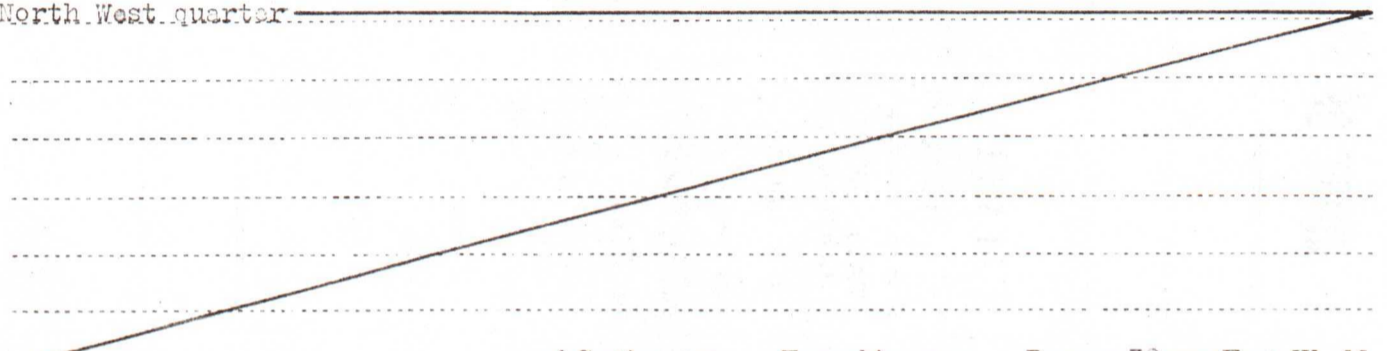

has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Thirty (30) feet wide, being Thirty (30) feet on the South side of the center line of said road, as surveyed over and across

North West quarter



of Section 12, Township 5 N, Range 32 East W. M.

Beginning at a point known as station 119/86 on the Vansycle-Juniper Highway, which point is approximately on the quarter section corner common to sections 1 and 12, T 5 N, R 32 E.W.M. running thence S 86° 06' W, a distance of 1321.4 ft. thence on a 4° C.R. the central angle of which is 6° 00', a distance of 150 ft. to a point known as station 133/57.4, which point is approximately 1950 ft. East and 10 ft. N of Section corner common to sections 1-2-11-12, T 5 N, R 32 E.W.M. Said parcel of land containing 0.32 acres of land more or less.
