the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in

the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on

each side of the center line of said road, as surveyed over and across

the West half of Section 12 Township 5 North Range 32 East W. M.

Beginning at Station 141 & 95 of the said Highway Survey

which Station is approximately 455 feet East and feet of the Station Corner

which is common to Sections 1, 2, 11 and 12 Township 5 North Range 32 East W. M.

Thence running in a S. 73. 20' N. direction approximately 481 feet to Station 146 & 76 of

the said survey, which Station is approximately 20 feet South and feet of

the Section corner which is common to Sections 1, 2, 11 and 12 Township 5 North,

Range 32 East W. M. Contains 0.45 acres more or less.
