

In The Matter of Oregon Road,

known as the HELIX - VANSYCLE MARKET ROAD

Know all men by these presents, That Prudence E. Killian, an unmarried woman,

of the County of Umatilla,

in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of One Dollar

paid to her the receipt whereof is hereby acknowledged

has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, State of Oregon, to-wit:

A strip of land 60 feet wide, being 30 feet wide on each side of the center line of the Helix-Vansycle Market Road as surveyed over and across the West Half of Section 5, Township 5 North, Range 33 East, W.M. and as more particularly described as follows: Beginning at a point on the Quarter Section line, 1456 feet North of the Quarter Section corner common to Sections 5 and 8, thence North 53° 24' West, 0.0 feet, thence on a 1432.5 feet radius curve right, 553.3 feet, thence North 36° 04' West, 1128.7 feet, thence on a 573.0 feet radius curve left, 204.5 feet, thence North 56° 31' West, 128.0 feet, thence on a 1432.5 feet radius curve right, 262.6 feet, thence North 45° 59' West, 297.6 feet, thence on a 102.3 feet radius curve left, 186.0 feet, to a point in the center of the Vansycle-Juniper Market Road, which point is 880 feet North and 1670 feet West of the Center of Section 5. Also, beginning at Station 233 + 59.8 P.C. of the above mentioned center line survey, thence on a 102.3 feet radius curve right, 148.8 feet to a point in the center of the Vansycle-Juniper Market Road, which point is 730 feet North and 1775 feet West of the Center of Section 5. All in Township 5 North, Range 33 East, W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.

The Grantee, herein, as part of the consideration aforesaid, agrees to build a good and substantial three wire fence with cedar posts a road apart on each side of the above described right of way and also to construct a stock crossing under the said roadway.

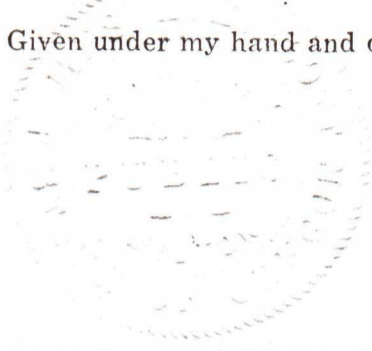
