has granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto

the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in

the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on

each side of the center line of said road, as surveyed over and across

North West quarter

of Section 7 Township 5 N, Range 33 East W. M.

Beginning at a point known as station 64/77.1 on the Vansycle-Juniper Survey Highway, which point is approximately 332 ft. west and 10 ft. N of quarter section corner common to sections 6-7, T 5 N, R 33 E.W.M. Corner running thence on a 10° C.R. the central angle of which is 8° 12', a distance of 82 ft. thence S. 89° 43' W, a distance of 1373.2 ft. thence on a 10° C.L. the central angle of which is 22° 40' a distance of 226.7 ft. thence S, 67° 08' W, a distance of 431.6 ft. thence on an 8° C.R. the central angle of which is 20° 24' a distance of 25.5 ft. to a point known as station 92/92.0 on the Vansycle-Juniper Highway. Said point being approximately 260 ft. south of section corner common to sections 1-12-6 and 7, T 5 N, R 32 and 33 E.W.M. Said land containing 1.43 acres more or less.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
