has granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on each side of the center line of said road, as surveyed over and across Lot No. 9, Section 22, Township 3 North, Range 36 East, W.M. Beginning at the Southwest corner of said Lot No. 9, thence in a general easterly direction following along the north bank of the Umatilla River and about 30 feet therefrom, approximately 1650 feet to a point on the Section line between Sections 22 and 23 approximately 370 feet south of the Quarter Section corner common to Sections 22 and 23, all in Township 3 North, Range 36 East, W.M.
