

IN THE COUNTY COURT OF THE STATE OF OREGON FOR UMATILLA COUNTY

In the Matter of Locating, Establishing, Altering, Widening, Straightening, and Changing a County Road being a part of The Mission-Thorn Hollow County Road over a portion of Section 1, Twp. 2N, Range 34, and Secs. 6 and 5, Twp. 2N 35, E. W. M.

REPORT OF COUNTY ROAD VIEWERS.

TO THE HONORABLE COUNTY COURT OF THE STATE OF OREGON FOR UMATILLA COUNTY.

We, the undersigned board of County road viewers heretofore instructed to view the above mentioned proposed road submit the following report.

Pursuant to your Order, we met at the point of beginning of the above mentioned proposed road on the 12th day of March, 1931, and having qualified as viewers proceeded to view the proposed road.

We find the road as located and laid out to be a feasible and necessary one and a benefit to the public, therefore, we respectfully recommend that it be opened and established as a County Road of Umatilla County, Oregon.

We find that the Nictetas allotment No. W.W.457 in the NW $\frac{1}{4}$ of Section 1, Township 2N, Range 34. E.W.M., is damaged in the amount of twenty dollars, this covers the cutting of trees and a right of way sixty feet wide, thirty feet wide on each side of the center line of the road survey as surveyed, the old right of way will be returned to the owner of the land which is crossed.

Pocootspum allotment No. W.W.474, in the SW $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 1, Township 2N, Range 34, E.W.M., is damaged in the amount of twenty dollars, which covers the cutting of trees and a right of way, thirty feet wide on each side of the center line of the road survey as surveyed. The old right of way will be returned to the owner of the land which it crosses.

Semkawetla allotment No. W.W. 7, in the SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 1, Township 2N, Range 34, E.W.M., is damaged in the amount of thirty five dollars, which covers right of way thirty feet wide on each side of the center line of the road surveyed as surveyed, and the cutting of trees. The old right of way will be returned

to the owner of the land which it crosses.

Samuel Minthorn allotment No. 1072 in the SW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 6, Township 2N, Range 34, E.W.M., is damaged in the amount of twelve dollars fifty cents (\$12.50), this is to cover right of way thirty feet wide on each side of center line of road survey as as surveyed, and cutting of trees; also the County is to fence the right of way with a three wire barb wire fence with posts 16 $\frac{1}{2}$ feet apart where the road cuts into cultivated land. Any of the old right of way which is not used will be returned to the owner of the land which it crosses.

Netzatelaki allotment No. C107 in the SE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 6, Township 2N, Range 35, E.W.M., is damaged in the amount of twelve dollars fifty cents (\$12.50), and is entitled to a three wire barb wire fence along the south side of the right of way. This amount covers the right of way thirty feet wide on each side of the center line of the road survey as surveyed. Any of the old right of way which is not used will be returned back to allotment No. C107.

Shemawmoosh allotment No. W.W.117 in the SW $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 6, Township 2N, Range 35, E.W.M., is damaged in the amount of twenty dollars. This amount covers the right of way thirty feet wide on each side of the center line of the road survey as surveyed, and the cutting of trees. Any of the old right of way which is not used will be returned to allotment No. W.W.117.

Saplakowmish heirs or allotment No. C144 is damaged in the amount of ten dollars for the cutting of apple trees, other than this there is no damage whatsoever.

We recommend that the above mentioned road be opened and other than the above mentioned damages the property owners are damaged in the amount of nothing.
