

In the Matter of Locating, establishing, Altering, Widening, Straightening, and Changing a County Road being part of the Mission-Thorn Hollow County Road over a portion of the Northwest Quarter of Section 10, Township 2 North, Range 34, E.W.M.

REPORT OF COUNTY ROAD VIEWERS.

TO THE HONORABLE COUNTY COURT OF THE STATE OF OREGON FOR UMATILLA COUNTY.

We, the undersigned board of County Road Viewers heretofore instructed to view the above mentioned proposed road submit the following report.

Pursuant to your Order, we met at the point of beginning of the above mentioned proposed road on the 5th day of February, 1931, and having qualified as viewers proceeded to view the proposed road.

We find the road as located and laid out to be a feasible and necessary one and a benefit to the public, therefore, we respectfully recommend that it be opened and established as a County Road of Umatilla County, Oregon.

The NW $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 10, Township 2N, Range 34 E.W.M., is damaged in the amount of \$90.00 per acre for that part of the land which is used for right of way purposes, and \$45.00 per acre for the land left in the Northwest corner of the above description, which is cut off from the main body of said land. The right of way containing 1.56 acres at \$90.00 per acre being \$140.40. The said Northwest corner of land which is effected and damaged at the rate of \$45.00 per acre containing 2.97 acres, being \$133.65. The total damage being in the amount of \$274.05. 133.65

We find that the Mumsow allotment No. 1057 in the SE $\frac{1}{4}$ of NW $\frac{1}{4}$ of Section 2, Township 2N, Range 34 E.W.M., is damaged in the amount of \$5.00.

Ayusha-Katsagon allotment No. C-341 in the SW $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 2, Township 2N, Range 34 E.W.M., is damaged in the amount of \$5.00.

Allotment No. 826 in the SE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 2, Township 2N, Range 34, E.W.M., is damaged in the amount of \$25.00, and that both sides of right of way should be fenced with a three wire barb wire fence from Station 504/50 to Station 509/80 of the survey.

Allotment No. W-457 over the S $\frac{1}{2}$ of NW $\frac{1}{4}$ of Section 1, Township 2N, Range 34, E.W.M., is damaged in the amount of \$50.00. This damage covers the right of way crossing the above described property, and cutting off trees. Also the right to maintain a camp on the said property during the construction of said road.
