The notice consisted of copies of the Notice of Public Hearing and was served by certified mail on each person found to have recorded interests in real property abutting the proposed vacations.

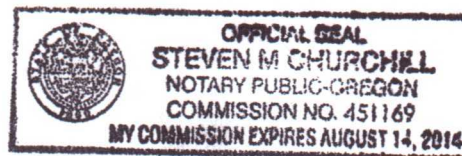
