

RELINQUISHMENT OF TITLE

KNOW ALL MEN BY THESE PRESENTS, That STATE OF OREGON, by and through its STATE HIGHWAY COMMISSION, hereby relinquishes and conveys unto UMATILLA COUNTY, a political subdivision of the State of Oregon, its right, title and interest in and to the following described property, only so long as used for the purposes hereinafter stated, to wit:

PARCEL 1 (P-12) To be used for public park and viewpoint purposes.

E $\frac{1}{2}$ of Lot 2 of Section 6, Township 1 North, Range 34 East, W.M., Umatilla County, Oregon, containing 20.16 acres.

PARCEL 2 (9644-C) To be used for public purposes.

A parcel of land lying in the NW $\frac{1}{4}$ of the SW $\frac{1}{4}$ of Section 5, Township 1 North Range 34 East, W.M., Umatilla County, Oregon, and being a portion of the following described property: That tract of land which was conveyed by that certain deed to Arthur Greer, recorded in Book 129, Page 196 of Umatilla County Record of Deeds, the said parcel being described as follows:

Beginning at a point on the West line of said Section 5; said point being 106.3 feet South from the West quarter corner of said Section 5; thence South 69° 05' East, 558 feet; thence South 20° 55' West, 100 feet to the Northerly right of way line of the Old Oregon Trail Highway; thence North 69° 05' West along said right of way line, 264.9 feet; thence on a 1001.74 foot radius curve right (the long chord of which bears North 61° 14' West, 272.9 feet) a distance of 273.9 feet to the West line of said Section 5; thence North 1° 00' East along said West line, 66.7 feet to the place of beginning, containing 1.17 acres.

PARCEL 3 (Q-252) To be used for public purposes.

A parcel of land lying in the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 9, Township 2 North, Range 33 East, W.M., and being more particularly described as follows:

Beginning at a point which is the intersection of the West line of Section 9, Township 2 North, Range 33 East, W.M., and the Northerly right of way line of the Old Oregon Trail Highway, said point being 30 feet distant from (and measured at right angles to) the center line of said highway at Engineer's Station 151+03.5; said point also being 975 feet North and 1.1 feet East of the quarter corner common to Sections 8 and 9, Township 2 North, Range 33 East, W.M.; thence (along the Northerly right of way line of said highway) on a 1667.1 foot radius curve to the right (the long chord of which bears South 65° 54' East, 412.57 feet) a distance of 413.6 feet; thence South 58° 47' East, a distance of 1043.2 feet; thence on a 1402.5 foot radius curve to the left (the long chord of which bears South 60° 09' East, 66.7 feet) a distance of 66.7 feet to a point which is the intersection of the said highway right of way line and the East line of the aforementioned SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 9; thence (following said East line of the SW $\frac{1}{4}$ of the NW $\frac{1}{4}$ of Section 9) North 0° 16 $\frac{1}{2}$ ' West, a distance of 732.05 feet to the Southerly right of way line of the O.W.R.R. & N. Company; thence (following the said O.W.R.R. & N. Co. right of way line) on a 1769.1 foot radius curve to the right (the long chord of which bears South 88° 24' West, 309.4 feet) a distance of 310.8 feet; thence North 86° 34' West, a distance of 1015.65 feet to the West line of said Section 9; thence following said section line South 0° 04' West, a distance of 41.9 feet to the point of beginning; containing 10.69 acres, more or less, in Umatilla County, Oregon.

PARCEL 4 (S-216, S-283) To be used for public purposes.

A parcel of land lying in Section 25, Township 2 North, Range 33 East, W.M., Umatilla County, Oregon; the said parcel being that property described in those deeds to the State of Oregon, by and through its State Highway Commission, recorded in Book 130, Page 324 and in Book 130, Page 369 of Umatilla County Record of Deeds.

The parcel of land to which this description applies contains 1.81 acres, more or less.

The real property hereinabove described is no longer needed or required by Grantor for state highway, scenic or park purposes.
