RELINQUISHMENT OF TITLE

KNOW ALL MEN BY THESE PRESENTS, That the STATE OF OREGON, by and through its DEPARTMENT OF TRANSPORTATION, Highway Division, hereby relinquishes and conveys unto UMATILLA COUNTY, a political subdivision of the State of Oregon, its right, title and interest in and to the following described property, only so long as used for public road purposes, to wit:

That certain real property consisting of 3 parts situated in Section 12, Township 2 North, Range 32 East, W.M. and in Sections 7, 8, 9 and 14, Township 2 North, Range 33 East, W.M., Umatilla County, Oregon.

Part 1 being that property described in that deed to the State of Oregon, by and through its State Highway Commission, recorded in Book 130, Page 545 of Umatilla County Record of Deeds.

ALSO that portion of that property designated as Parcel 2 and described in that deed to the State of Oregon, by and through its State Highway Commission, recorded in Book 150, Page 469 of Umatilla County Record of Deeds lying Easterly of a line at right angles to the center line of the relocated Old Oregon Trail Highway at Engineer's Station 94+00, which center line is described in that certain judgment, dated September 13, 1954, entered as Circuit Court Case No. 6573, Umatilla County, Oregon.

Part 2 being that property described in those deeds to the State of Oregon, recorded in Book 143, Page 570 and in Book 144, Page 586 of Umatilla County Record of Deeds.

ALSO that property described in that deed to the State of Oregon, by and through its State Highway Commission, recorded in Book 130, Page 455 of Umatilla County Record of Deeds.

Part 3 being that property described in those deeds to the State of Oregon, recorded in Book 143, Page 244; Book 130, Page 415 and in Book 130, Page 416 of Umatilla County Record of Deeds.

This relinquishment is made and executed in furtherance of that certain Highway Commission Resolution of November 3, 1955 and that Agreement entered into by the parties herein, dated January 18, 1954. The property herein relinquished is no longer needed or required for state highway, park or scenic purposes.

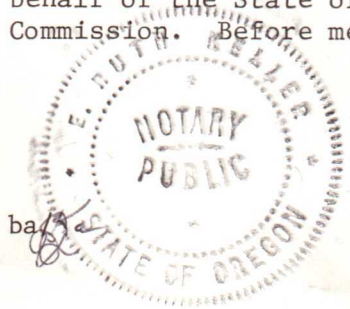
