In the matter of Oregon Road, known as the Oregon-Washington Highway

Know all men by these presents, That Charles E. Merritt, Trustee for H. Paul Johnson, Marianna Bunker, estate of Frank W. Merritt and estate of Helen M. Burrill and his wife, of the County of Umatilla

in the State of Oregon. in consideration of the benefits and other valuable considerations, and the sum of Fifty and no/100 Dollars,

paid the receipt whereof is hereby acknowledged,

has granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situated in Umatilla County, in the State of Oregon, to-wit: A strip of land feet wide

All that part of the property of Charles E. Merritts, (trustee) in lot 4, blk 5, original town of Adams, included within a strip of land 40 feet wide, being 20 feet on each side of the center line of the Oregon - Washington Highway No. 8, as surveyed over and across said property, said center line being more particularly described as follows:-

Beginning at a point on the south line of lot 4, blk. 5, original town of Adams, said point being approximately 1390.0 feet east and approximately 1325.0 feet south of the 1/4 section corner between sections 3 and 4, T3N.R34 E., W.M. Umatilla county, State of Oregon, said point being approximately 12 feet east of the south west corner of said lot 4, blk. 5, original town of Adams thence on a 20° curve to the right, whose central angle is 90° 38', 48.0 feet to the north line of lot 4, blk. 5, original town of Adams, said point being approximately 40 feet east of the north west corner of lot 4, blk. 5, original town of Adams; said tract of land containing 0.05 acres of land more or less.

All that part of the property of Charles E. Merritts (trustee) in lot 7, blk. 5, original town of Adams, included within a strip of land 40 feet wide, being 20 feet on each side of the center line of the Oregon- Washington Highway No. 8, as surveyed over and across said property, said center line being more particularly described as follows:-

Beginning at a point on the west line of lot 7, blk. 5 original town of Adams, said point being approximately 1262.0 feet east and approximately 1205.0 feet south of the 1/4 section corner between sections 3 and 4, T3N,R34E, W.M. Umatilla county, State of Oregon, said point being also approximately 5 feet south of the N.W. corner, of lot 7, blk. 5, original town of Adams; thence on a 20° curve to the right, whose central angle is 90° 38', 7.0 feet to the north line of lot 7, blk. 5, original town of Adams, said point being approximately 5.0 feet east of the N.W. corner of said lot 7 blk. 5, original town of Adams, said tract of land containing 0.01 acres of land more or less.
