R. 33 E. W.M.: Beginning at a point 1158 feet South and 792 feet East of the Center of Section 29, thence North 49° 14' West, 219.3 feet, thence on a 10 curve left, 200.2 feet, thence North 69° 16' West, 75.5 feet, thence on a 16 curve right, 240.7 feet, thence North 30° 45' West, 43.1 feet, thence on a 16 curve left, 110.5 feet, thence North 48° 26' West, 13.1 feet, thence on a 10 curve right, 260.7 feet, thence North 22° 22' West, 97.2 feet, thence on a 16 curve right, 164.7 feet, thence North 3° 59' East, 58.2 feet, thence on a 12 curve right, 82.8 feet to a point on the Quarter Section line, 92 feet West of the Center of Section 29, all in Township 3 North, Range 33 East, W.M.
