has granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, State of Oregon, to-wit: A strip of land sixty feet wide being thirty feet on each side of the center line of the Despain Gulch Market Road as surveyed over and across the Northeast Quarter of Section 4 Township 3 North, Range 31 East, W.M. and as more particularly described as follows:

Beginning at a point on the section line 380.0 feet South of the Northwest corner of Section 3, Township 3 North, Range 31 East, W.M. which point is known and designated as station 371/84.4 thence North 25°03' West 0.0 feet, thence on a 1432.5 foot radius curve left 43.4 feet, thence North 26°47' West 1676.2 feet, thence on a 1146.0 foot radius curve left 815.7 feet, thence North 67°34' West 223.2 feet, thence on a 955.0 foot radius curve right 245.3 feet, thence North 52°51' West 465.9 feet, thence on a 5730.0 foot radius curve left 511.7 feet to a point on a section line 260.0 feet South of the center of section 33, Township 4 North, Range 31 East, W.M. which point is known and designated as station 411/67.5.
