Beginning at a point 908 feet East of the Quarter section corner common to sections 16 and 17, T. 3 N., R. 32 E. W.M., thence N. 79°04' W. a distance of 3615.0 feet to a point 640 feet North of the center of section 17, T. 3 N., R. 32 E. W.M.

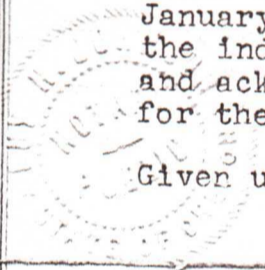
