 Section Seventeen (17) thence West on the  
 Section line between the South west

 West quarter of Section Twenty (20) and  
 the South East quarter of Section Eighteen (18)  
 and the North West quarter of Section Nineteen  
 (19) to the North West corner of the North  
 East quarter of said Section Nineteen  
 (19) all in Township Three (3) North of  
 Range Three (33) East Will Mer

 ers will ever pray.
