(NOTICE OF HEARING OF DEPUTY ROADMASTERS REPORT FOR VACATING OF SAID HIGHWAYS.

Public notice is hereby given that the above entitled court, has by resolution adopted on the 28th day of July, 1933, declared its intentions to vacate a road or highway, more particularly described as follows:

Beginning at a point which point is approximately one quarter mile west of the quarter corners common to sections 19 and 20, Township 4 South, Range 32, E.W.M. thence east one half mile; thence south one mile to a point which point is approximately one quarter mile east of the quarter corners common to sections 29 and 30, township 4 south, range 32, E.W.M.

You are further notified that the Deputy Roadmaster of Umatilla County, Oregon, has examined said road and made and filed with the Clerk of this Court his report in writing, which report was filed on the 29th day of July, 1933, recommending a vacation of said road.

ALL PERSONS interested in, or concerned with that portion of the county road above described, are hereby notified that said road has been examined by said Deputy Roadmaster, and his report filed recommending that said roadway be vacated, and that the county court of Umatilla County, Oregon, will, at their regular term, on the 31st day of August, A.D. 1933, at the hour of ten o'clock A.M. of said day, at the county court room, in the county court house, Pendleton, Oregon, hold a hearing on said report and hear and consider said report, together with the resolution, a copy of which is attached to this notice, marked exhibit "A" and by reference made a part hereof, and any and all objections that may be made to the vacation of said road above described.

The Deputy Roadmaster of Umatilla County, Oregon, is hereby directed and ordered to post the above notices, in three public places in the vicinity of said road, and at the place of holding County Court, thirty days previous to the 31st day of August, 1933.

NOW on this day this matter coming on to be heard for final hearing, and it appearing to the Court that a Resolution was adopted on the 12th day of January 1932 by this Court, and entered in its journal, declaring that proceedings to vacate the hereinafter described highway would be undertaken, and

It further appearing to the court, that the Roadmaster of Umatilla County, Oregon has been notified of said proceedings, and has made and filed herein his report in writing, recommending a vacation of the said road, and

It further appearing that due and legal notice was given by this court, in the manner provided by law, of the hearing upon said report of said Roadmaster, and that no objections or remonstrances have been made or filed herein, nor has any person or persons appeared adversely thereto, and that more than 30 days have elapsed since said notice was given and posted as required by law, and

It further appearing to the Court that on the day set for the hearing of said report of said Roadmaster, this Court did consider said report together with the said Resolution, and no remonstrances having been filed, nor any person or persons objecting thereto, and the Court being now and here satisfied that said road is useless as a part of the general road system, is burdensome to maintain, and that the public will be benefited by its vacation, and that the report of said Roadmaster is just and fair and favorable to the court, the same is now hereby adopted, and the hereinafter described road, to-wit:

Commencing at the North line of Section 3, Township 3 North Range 32 E. W. M., thence South through the center of Sections 3, 10 and 15 in said Township and Range to the South line of said Section 15,

Be and the same is hereby vacated. It is further ordered that this order be entered Nunc pro tunc, as of the 7th day of March, 1932.
