

REPORT OF BOARD OF COUNTY ROAD VIEWERS

IN THE MATTER OF VIEWING, SURVEYING AND LAYING OUT
COUNTY ROAD NO. 585

TO THE HONORABLE COUNTY COURT OF THE STATE OF OREGON, FOR UMATILLA COUNTY.

WE, THE UNDERSIGNED Board of County Road Viewers, heretofore instructed to view, survey, and locate Road No. 585, submit the following report:

Pursuant to an order of the Honorable County Court, we met at The County Surveys Office in Pendleton Oregon, on the 7th day of May 1906

who were by the Surveyor each duly sworn. We viewed, surveyed, and located said Road No. 585, as specified in our order. We find said route practicable, has been traveled and continuously in use as a public highway by the land owners along the route, and the general public for the past 14 or 15 years, is absolutely necessary as a public highway. We therefore recommend the same be established, and declared a public highway of Umatilla County Oregon. The cost of repairs and additional improvements necessary would be about \$950⁰⁰.
