RESOLUTION

County Road No. 871

TO ALL PERSONS WHOM IT MAY CONCERN:

WHEREAS, it is deemed advisable that a County Road or Highway be located, established, altered, widened, straightened and changed crossing the West Half of Section 12, Township 1 South, Range 32 East, W.M.

and that said Road or Highway be located, established, altered, widened, straightened and changed by resolution of the County Court of Umatilla County, State of Oregon.

AND WHEREAS, this being a regular term of the Umatilla County Court and the said Court being now in regular session, sitting for the transaction of County Business with all members of said Court present.

NOW, THEREFORE, BE IT RESOLVED by the County Court of Umatilla County, State of Oregon, sitting at the regular monthly term for the month of March 19 27, in the County Court Room of the Court House, in Pendleton, Umatilla County, State of Oregon, for the transaction of County business, that it is and is hereby declared to be the intention of the said County Court to locate, establish, alter, widen, straighten and change a road or highway on and over a route as follows:

BE IT RESOLVED that the proposed County Road

shall commence, run and terminate as follows, to-wit:

Beginning at a point in the center of County Road No. 531, 51.7 feet North and 635.7 feet West of the Quarter Section corner common to Sections 1 and 12, thence Southwesterly following the west side of the draw across the West Half of Section 12, to a point in the center of County Road No. 438, 572.5 feet South of the Quarter Section corner common to Sections 11 and 12. All in Township 1 South, Range 32 East, W.M.

The right of way or roadway to be a strip of land sixty feet wide, being thirty feet wide on each side of the above described line.

BE IT FURTHER RESOLVED that a public necessity for the said road or highway is hereby declared to exist for the following reasons, to-wit: That it eliminates a steep and rock hill and provides an outlet for the upper McKay Creek country to Pilot Rock.

BE IT FURTHER RESOLVED that true copies of this Resolution, properly certified to as such by the County Clerk, be posted by the County Roadmaster as follows, to-wit: That a copy be posted upon the bulletin board in the west corridor of the County Court House in Pendleton, Oregon, said Court House being the place where the County Court is held; That three copies be posted in three public places in the vicinity of the said proposed road; And that this Resolution be duly entered in the Commissioners Journal.
