In the matter of a County Road

Comm at a point in the boundary line of Millton City 30 ft E of the N and S line, passing through the center of the SW 1/4 of Sec 1. Th S N R 35 E. W. M. Running thence N parallel with and distant 30 ft and distant 30 ft from said N and S 1/4 sec center line to a point 30 ft N of the N boundary line of said S. W. 1/4 of Sec 1, Th N. parallel with N line of SW 1/4 of said Sec 1 to a point on the E line of the County Road known as the Middle Road leading from Millton to Walla Walla Park. Thence 60 ft S along the E line of said road. Th E and S parallel with and 60 ft distant from the first two lines heretofore described and located to the boundary line of said Millton City, Th E to the place of beg.

It is therefore ordered by the Court that said road be established as a county road in accordance with the report of said viewers, and that the report of said viewers, field notes and plat of survey thereof, be recorded as by law required and that the Supervisor through whose district said road runs be directed to open the same for public use as a County Road.

R. 32 E. W. M. to a point Marked R.

Com at initial point in Road Survey #342, a sawdust pier 4 in sq. marked M on W face and S on S face, near head of grade on W side of lower crossing of McKay Crk. in SE cor Sec 20, T2, N.R. 32 E. Following said Road Survey #342, the 60 ft intersection with the line bet. Secs 29 & 32 in said Tp. Th up a certain run line to intersect the line bet Secs 5 & 6 in T2, N.R. 32 E. at a point about 150 yards S of cor to Secs 5, 6, 31 & 32, Th S along sec line to the 1/4 sec Cor between said Secs 5 & 6; Th N to intersect said Road Survey #342; th along said survey #342 as near as may be for the best road to its terminus; Th continuing up Combs' Cañon, on best route to Scale's well, Th up the N fork of Combs' Cañon on best route to intersect line bet Secs 30 & 31 E & W.
