R E S O L U T I O N

WHEREAS, Leonard Lorenzen and Bertha Lorenzen are the owners of the following described real estate, situated, lying and being in the County of Umatilla, State of Oregon:

The South Half of Section 35, T4N, R30 E.W.M. (Book 236, page 251) and the Northwest Quarter of Section 2 T3N, R30 E.W.M. (Books 175, 179 and 206, pages 327, 575 and 455 respectively).

WHEREAS, it is desired by the Umatilla County Court and the Umatilla County Road Department to vacate the following described portions of County Road #82, to-wit:

Beginning at Engineers center line station 0+00, said station being 1,835.95 feet North and 641.45 feet West of the Southeast corner of said Section 35 T4N, R30 E.W.M.; Thence S87°02'W-394.18 feet to the Engineers center line Station 4+00 the point of beginning to vacate all of that part westerly of the said point in Sections 35, T4N, Section 2 and 3 in T3N; all in R30 E.W.M., described as follows:

Thence S64°22'W-1500.0 feet; Thence S52°42'W-1800.0 feet; Thence S60°04'W-900.0 feet; Thence N89°36'W-250.0 feet; Thence N70°40'W-500.0 feet; Thence N40°45'W-248.8 feet; Thence N22°37'W-385.2 feet to a point which is (more or less) the North line of the said Section 3 T3N, R30 E.W.M., and Engineers Re-located center line station 63+64.8.

WHEREAS, due to the flood conditions of December 22, 1964, it is desired by the Umatilla County Court and the Umatilla County Road Department to reconstruct and relocate portions of said County Road #82, as per the terms of ORS 368.540, which center line is described as follows:

A parcel of land lying in the South half of the Section 35, T4N; and the North half of Section 2, T3N, all in Range 30 E.W.M., the said parcel being that portion of said South half included in a strip of land 60 feet in width, 30 feet on each side of the center line of Stage Gulch Road No. 82 as said County Road has been relocated (Under ORS 368.540) which center line is described as follows:

Beginning at Engineer's center line station 0+00, said station being 1,835.95 feet North and 641.45 feet West of the Southeast corner of said Section 35, T4N, R30 E.W.M.; Thence on the arc of 674.1 feet radius curve left (the long chord of which bears S75°52'W)-662.7 feet; Thence S47°42'W-1387.3 feet; Thence on the arc of 5,730.0 feet radius curve left (the long chord of which bears S46°12'W)-300.0 feet; Thence S44°42'W-381.3 feet; Thence on the arc of 955.0 feet radius curve right (the long chord of which bears S54°42'W)-333.3 feet; Thence S64°42'W-135.4 feet; Thence on the arc of 5,730.0 feet radius curve left (the long chord of which bears S63°12'W)-200.0 feet; Thence S61°42'W-799.9 feet; Thence on the arc of 1,910.0 feet radius curve right (the long chord of which bears S64°42'W)-200.0 feet; Thence S67°42'W-151.7 feet; Thence on the arc of 573.0 feet radius curve right (the long chord of which bears S82°12'W)-290.0 feet; Thence N83°18'W-266.4 feet; Thence on the arc of 573.0 feet radius curve right (the long chord of which bears N64°48'W)-370.0 feet; Thence N46°18'W-0.5 feet; Thence on the arc of 1,146.0 feet radius curve right (the long chord of which bears N42°16'W)-121.5 feet to the Engineer's center line station (Point on Curve) 56+00, said center line intersecting the South line of the said South half of Section 35 approximately at station 29+00 and the West line of the said North half of Section 2 approximately at station 55+36.

The parcel of land to which this description applies contains 6.8 acres.

WHEREAS, on the 7<sup>th</sup> day of June, 1965, Leonard Lorenzen and Bertha Lorenzen, husband and wife, have by bargain and sale deed conveyed the above described real property to Umatilla County to be dedicated as a public road.

THEREFORE, IT IS ORDERED that County Road #82 in Section 35, Township 4 North, Range 30 E.W.M., Section 2 Township 3 North, Range 30 E.W.M., be, and the same is hereby in part vacated, altered, and relocated as indicated herein.
