have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, State of Oregon, to-wit: A strip of land sixty feet wide, being thirty feet

wide on each side of center line of the Yoakum Stage Gulch Market Road as surveyed over

and across the Northwest Quarter of the Northwest Quarter of Section 1, Township 2, North Range 30, East, W. M. The above mentioned center line being more particularly described

as follows: Beginning at a point on a section line 745.5 feet South of the Northwest Section Corner of Section 1, Township 2, North Range 30, East, W. M. which point is known

and designated as station 43-38.0 P.O.T. Thence North 65° 52' East 231.9 feet, thence North 35° 49' East 308.9 feet, thence North 36° 19' East 414.6 feet thence North 55° 03'

East 101.6 feet, to a point on a section line known and designated as station 53-95.0 I.O.T. which point is 715.0 feet East of the Northwest Section Corner of Section 1,
