TO THE HONORABLE COUNTY COURT OF THE STATE OF OREGON FOR UMATILLA
COUNTY:

We, the undersigned Board of County Road Viewers, heretofore
instructed to view the above mentioned road, submit the following report;

Pursuant to your order we met at the begining point of said
road on the 22nd day of July, 1926 and having qualified as viewers proceed-
ed to view said road.

We find that the following described route, following closely
the description in the above mentioned petition and having the same termini,
will make a feasible and necessary road and one beneficial to the public;
Begining at the Quarter Section corner common to Sections 12 and 13, Township
4 North, Range 28 East, W.M., thence running Northeasterly following a
straight line as closely as practicable to a crossing over the U. S. Feed
Canal at the reverse curve in said Feed Canal in the South Half of the
Northwest Quarter of Section 8, T. 4 N. R. 29 E., W.M., thence crossing said
U. S. Feed Canal and continuing Northeasterly, following a straight line as
closely as practicable to a point on the East and West 1/16 section line
through the middle of the North half of Section 9, T. 4 N. R. 29 E., W.M.,
Said point being app roximately 150 feet East of the center of the said
U. S. Feed Canal, thence East, following the above mentioned 1/16 section
line through Section 9, T. 4 N. R. 29 E. W.M. to a point in the Northwest
Quarter of Section 10, T. 4 N. R. 29 E. W.M., 30 feet North of ~~MMXXMMXXMMXX~~
~~XX~~ the north right of way line of the Furnish Ditch, thence easterly follow-
ing a line 30 feet north of and parallel to the north right of way line of
the said Furnish Ditch to an intersection with the East and West 1/16 Section
line through the middle of the North half of Section 10, T. 4 N. R. 29 E. W.M.
thence East following the above mentioned 1/16 Section line through Sections
10 and 11, T. 4 N. R. 29 E.W.M. to the Southeast corner of the Northeast
Quarter of the Northeast Quarter of Section 11, T. 4 N. R. 29 E.W.M. thence
Southeasterly to the Quarter Section corner common to Sections 12 and 13,
T. 4 N. R. 29 E. W.M. Said road to be Sixty feet wide, being thirty feet wide
on each side of the above described center line, excepting through and across
Section 9, T. 4 N. R. 29 E.W.M. said road to be sixty feet wide, being 12 feet
wide on the north side and 48 feet wide on the south side of said above
described center line.

Therefore we respectfully recommend that the route as described
above be opened and established as a County Road of Umatilla County, Oregon.

We find that the lands through which the above route is described will be made less valuable, by reason of the establishment of the said road, in the sum of nothing.
