ACCESS AND UTILITY EASEMENT

Windblown Ranch, Inc., A.K.A. Wind Blown Ranch, Inc., an Oregon corporation, Grantor, conveys and warrants to Windy River, an Oregon general partnership, Grantee, a perpetual non-exclusive easement for ingress-egress and utility purposes, the following described real property:

That portion of the Northwest quarter of the Southwest quarter of Section 28, Township 4 North, Range 29 East, Willamette Meridian, Umatilla County, Oregon, lying westerly of the westerly right-of-way margin of South Edwards Road, County Road Number 1201, described as follows:

Beginning at the Southwest corner of said Section 28; Thence North 00°55'51" West, along the West line of said Section 28 for a distance of 1319.38 feet, more or less, to the South one-sixteenth corner common to Sections 28 and 29, said Township and Range, said point also being the **True Point of Beginning** of the easement to be described;

Thence continuing along the West line of said Section 28, North 00°55'51" West, 60.01 feet; Thence leaving the West line of said Section 28, North 88°10'36" East, 2.26 feet to the westerly right-of-way margin of said South Edwards Road, being 30.00 feet westerly and at right angles to the centerline thereof; Thence South 00°13'27" West, along the westerly right-of-way margin of said South Edwards Road for a distance of 60.04 feet, more or less, to the South line of the Northwest quarter of the Southwest quarter of said Section 28; Thence leaving the westerly right-of-way margin of said South Edwards Road, along the South line of the Northwest quarter of the Southwest quarter of said Section 28, South 88°10'36" West, 1.05 feet to the **True Point of Beginning**.


