The undersigned hereby acknowledges that they knowingly and willingly waive the right to receive fair market value for the property illustrated on attached Exhibit "A" and the right to receive 90 days written notice before being required to give possession to the County of Umatilla. These rights are knowingly and willingly waived for the good of the people and mutual benefits derived. There is also waived any necessity and right for a public hearing on the proposed project. The County of Umatilla shall be responsible for the preparation of all legal instruments necessary for the conveyance of the property and any fees and costs in connection therewith. The County of Umatilla shall also obtain any necessary title insurance upon the property conveyed. The undersigned agree that they will promptly execute necessary legal instruments for the conveyance of this property, when same are prepared and presented. The County of Umatilla agrees to perform the following necessary obligations in connection with this project.

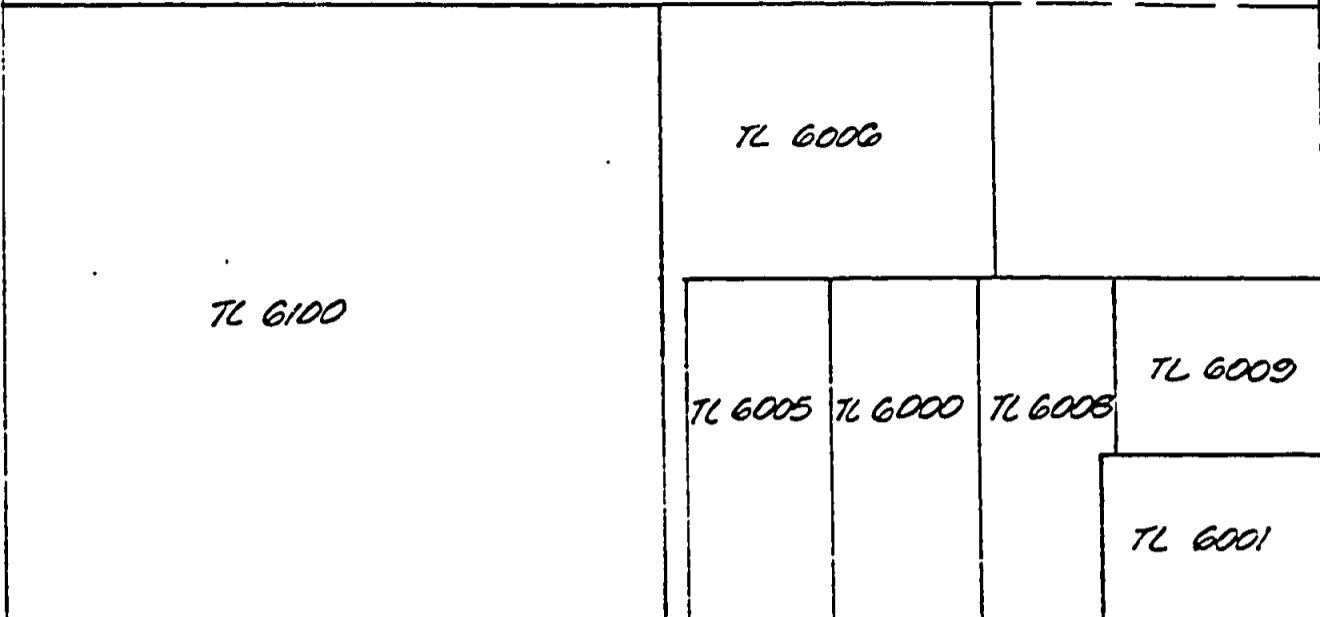

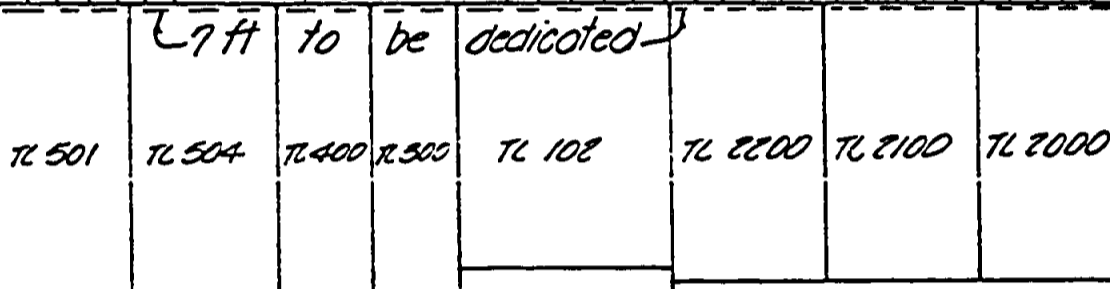

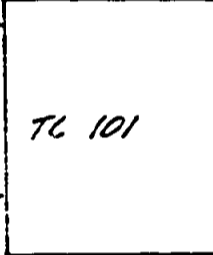
