Order No. RD 98-10

WHEREAS, in accordance with ORS 373.270(1)(b) the City of Hermiston, Oregon has deemed it to be in the best interests of the City to acquire jurisdiction over that portion of West Elm Avenue (County Road No. 1230) lying between County Road #1275 (Umatilla River Road) and County Road #1247 (NW 11th Street), and

WHEREAS, pursuant to ORS 373.270(6)(a) the City adopted Resolution No. 1508, passed by their Council and approved by their Mayor, requesting the transfer of the above described road from Umatilla County to the City, and

WHEREAS, pursuant to ORS 373.270(2)(a), (2)(b), and (3) notice of a public hearing was posted and published, and

WHEREAS, pursuant to ORS 373.270(4) a hearing was held on August 5, 1998, at 10:15 a.m. to hear public testimony both for and against the proposed transfer, and determining it to be in the public interest to transfer the above described portion of West Elm Avenue to the City of Hermiston:

IT IS HEREBY ORDERED that in accordance with ORS 373.270(6)(b) jurisdiction of the above described portion of County Road No. 1230 (West Elm Avenue) be transferred to the City of Hermiston, Oregon, and that improvement, construction, or repair by the County shall cease, and that the full and absolute jurisdiction over the road for all purposes of repair, construction, improvement, and the levying and collection of assessments shall vest in the City.

RESOLUTION NO. 1508

WHEREAS, the Hermiston City Council deems it necessary, expedient and in the best interests of the City of Hermiston to acquire jurisdiction over Elm Avenue between N.W. 11th Street and Diagonal Road and over N.W. 11th Street between W. Elm Avenue and W. Hermiston Avenue to the same extent as it has over other public streets and alleys of the City,

NOW, THEREFORE, the Hermiston City Council does hereby request the Umatilla County Board of Commissioners to initiate a proceeding to transfer jurisdiction over Elm Avenue between N.W. 11th Street and Diagonal Road and over N.W. 11th Street between W. Elm Avenue and W. Hermiston Avenue from Umatilla County to the City of Hermiston in accord with ORS 373.270.
