WHEREAS, in accordance with ORS 373.270(1)(a) the Umatilla County Board of Commissioners has deemed it to be in the best interests of the County to surrender jurisdiction over that portion of Theater Lane (County Road No. 1244) lying between U.S. Highway No. 395 and County Road No. 1219 (10th Street) and running along the east-west centerline of Section 2, Township 4 North, Range 28 E.W.M., and

WHEREAS, pursuant to ORS 373.270(4) a hearing was held on August 19, 1998, at 10:00 a.m. to hear public testimony both for and against the proposed transfer, and determining it to be in the public interest to transfer the above described portion of Theater Lane to the City of Hermiston:

IT IS HEREBY ORDERED that in accordance with ORS 373.270(5)(a) jurisdiction over the above described portion of County Road No. 1244 (Theater Lane) be offered to the City of Hermiston, Oregon, and that improvement, construction, or repair by the County shall cease, and that the full and absolute jurisdiction over the road for all purposes of repair, construction, improvement, and the levying and collection of assessments shall vest in the City upon their acceptance of the jurisdiction transfer.



NOW, THEREFORE, the Hermiston City Council does hereby accept Umatilla County Order Number RD 98-12, passed by the Board of Commissioners on August 19, 1998 to transfer jurisdiction over E. Theater Lane between U.S. Highway No. 395 and N.E. 10th Street from Umatilla County to the City of Hermiston in accord with ORS 373.270.
