have granted, bargained, sold and conveyed, and by these presents do..... grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, State of Oregon, to-wit: A parcel of land for road purposes over and across the Southwest $\frac{1}{4}$ of Section 9, Township 5 North, Range 28, E.W.M. It being more particularly described as beginning at a point 439.7 feet, more or less, North of and 1270 feet, more or less, East of the S.W. corner of Section 9, Township 5 North, Range 28, E.W.M., running thence North $0^{\circ} 29'$ West a distance of 536 feet, thence North $75^{\circ} 58'$ East a distance of 58 feet, more or less, to the North and South center line through the Southwest Quarter of Section 9, Township 5, North Range 28, E.W.M. running thence North and along the said North and South center line through the Southwest Quarter of Section 9, a distance of 330 feet, more or less, to the South line of Lot 4 in said Section 9; running thence South $0^{\circ} 29'$ East a distance of 862 feet, more or less, to the North right-of-way line of the 3rd. street extension road (running Northeasterly out of Umatilla, Oregon); thence South $74^{\circ} 11'$ West and along the North right-of-way line of the 3rd. street extension road a distance of 61.8 feet to the point of beginning.
