vey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in

Umatilla County, State of Oregon, to-wit: A parcel of ground for road purposes over and across the S.W.  $\frac{1}{4}$  of Section 9, Township 5, North Range 28, E.W.M. being more particularly described as beginning at a point 978 feet, more or less, North of and 1266 feet, more or less, East of the S.W. Corner of Section 9, Township 5, North Range 28, E.W.M.; thence N.  $0^{\circ}$  29' N. a distance of 342 feet, more or less, to the South line of Lot 4, Section 9, Township 5, North Range 28, E.W.M. running thence East a distance of 60 feet, more or less, to the North and South Center Line through the S.W.  $\frac{1}{4}$  of Section 9, thence running South and along the North and South Center Line through the S.W.  $\frac{1}{4}$  of Section 9 a distance of 330 feet thence South  $75^{\circ}$  58' West 58 feet to the point of beginning.

All located in the S.W.  $\frac{1}{4}$  of Section 9, Township 5 North Range 28, E.W.M. and containing 0.45 acres.

Also a parcel of ground for road purposes over and across the East portion of Lot 4 in Section 9, Township 5, North Range 28, E.W.M. being 60 feet wide, 30 feet on each side of the center line, being more particularly described as beginning at a point 1320 feet North of and 1293.3 feet East of the S.W. Corner of Section 9, Township 5, North Range 28, E.W.M.; thence North  $0^{\circ}$  29' West a distance of 525 feet to point, said point being the place of beginning of an  $8^{\circ}$  curve to the left, thence around an  $8^{\circ}$  curve to the left a distance of 100 feet, more or less, to the meander line of the Columbia River, containing 0.86 of an Acre.
