O R D E R

WHEREAS the Umatilla County Board of Commissioners held a public hearing on March 16, 1977, to relocate a portion of Old U.S. Highway #30, and

WHEREAS the hearing was requested by Kenneth and Alice Bowman, and

WHEREAS the portion of Old U. S. Highway #30 to be relocated has the following description:

Beginning at Old Oregon Trail Highway Engineers Station 1035+95.5 said Station being 2,494.80 feet North and 3,773.43 feet West of the SE corner of Section 9, Township 3 North, Range 29 East, W.M.; thence on a 8° curve right 281.3 feet; thence S 18° 46' W 57.9 feet; thence on a 2° curve right 405.8 feet; thence S 26° 53' W 1,008.2 feet; thence on a 28° curve left 358.4 feet; thence S 73° 28' E 606.7 feet; thence on a 24° curve right 241.7 feet the terminus point for this description.

WHEREAS the new centerline description is as follows:

A parcel of land lying in Section 9, Township 3 North, Range 29 East, W.M. for public road purposes. Said road being 50 feet in width, with 25 feet lying on each side of the following described centerline.

Beginning at a point 3,505.04 feet West of the SE corner of Section 9, Township 3 North, Range 29 East, W.M., the section corner being marked by a stone and said point being marked by a 1/2" iron rod; thence N 15° 31' W 368.23 feet, to the true point of beginning for this description; thence on a 1,432.40 foot radius curve right (the long chord of which bears N 9° 37' 30" W and 294.04 feet long) 294.6 feet; thence N 3° 44' W 1,844.0 feet, to the point of intersection with the Old Oregon Trail Highway Centerline Station 1036+05.5, the said point being 2,484.82 feet North and 3,772.78 feet West of the SE corner of Section 9, Township 3 North, Range 29 East, W.M.

WHEREAS a deed to the above described right-of-way was received from Kenneth and Alice Bowman, and

WHEREAS the Umatilla County Board of Commissioners, finding it in the best interest of the citizens of Umatilla County, ORDER the Umatilla County Roadmaster to relocate the portion of Old U.S. Highway #30 as requested and described in this Order.
