of Section—16—Township 2 North, Range—32—East W. M.

Beginning at a point on the quarter line between the $E\frac{1}{2}$ and the $W\frac{1}{2}$ of Sec. 16, T. 2 N.R. 32 EWM which point is approximately 1671.0 feet N. of the quarter section corner common to Sections 16 and 21, T. 2 N.R. 32 EWM running thence N. $48^{\circ} 35'$ E a distance of no feet, thence on a 1910.0 foot radius curve to the left a distance of 608.9 feet, thence N. $39^{\circ} 40'$ E. a distance of 201.0 feet, thence on a 1146.0 ft radius curve to the left a distance of 531.0 feet, thence N. $13^{\circ} 07'$ E a distance of 44.6 feet, which point is approximately 677.0 ft. N. and 975 ft. E of the $\frac{1}{4}$ corner common to Sections 15 and 16, T. 2 N.R. 32 EWM said parcel of land containing 3.29 acres, more or less.
