

DEDICATION DEED

16972

PROWLER INDUSTRIES OF OREGON, INC., an Oregon corporation, hereby forever dedicates and conveys to the use of the public for road or street purposes all or any portion of the following described land within Umatilla County, Oregon, to wit:

A tract of land lying in the N.W. 1/4 of Section 8, T2N, R32 E.W.M. More particularly described as follows;

Commencing at the S.W. Corner of that tract of land belonging to Prowler Industries of Oregon Inc., and recorded on Roll 2, Page 966, Umatilla County Deed Records;

Thence along the Westerly line of said tract N. 25° 22' 54" West a distance of 28.21 feet to the true point of beginning, said true point of beginning being a point on the Southerly boundary of that tract of land transferred to the County of Umatilla and recorded in Book 344, Page 203;

Thence along said Southerly boundary a distance of 53.85 feet along a 434.26 foot radius curve to the left to a point on the Southerly boundary of said tract belonging to Prowler Industries. Said curve having a L.C. of (N. 88° 33' 23" East a distance of 53.82 feet);

Thence along said Southerly boundary S. 57° 13' 36" West a distance of 20.65 feet;

Thence along a 444.26 foot radius curve to the right a distance of 31.63 feet to a point on the Westerly boundary of said tract belonging to Prowler Industries, said curve having a L.C. of (S. 89° 23' 28" West a distance of 31.62 feet);

Thence along said Westerly boundary N. 25° 22' 54" West a distance of 11.24 feet M/L to the true point of beginning.

Said tract of land contains .0098 acres M/L. All being in County of Umatilla, State of Oregon.




