WHEREAS by agreement dated June 26, 2014, the City of Pendleton and Umatilla County have determined that it would be in the public interest for the County to transfer jurisdiction of portions of the following roads to the City:

1. County Road No. 957 – N. E. 33<sup>rd</sup> Place (a.k.a. Tower Court)
2. County Road No. 1003 – N. W. Johns Lane
3. County Road No. 1302 – Murietta Road
4. County Road No. 1304 – McKennon Road
5. County Road No. 1306 – S. W. 28<sup>th</sup> Drive
6. County Road No. 1100 – Stage Gulch Road
7. County Road No. 1094 – Daniel Road
8. County Road No. 1319 – S. W. 27<sup>th</sup> Street
9. County Road No. 1307 – S. W. 44<sup>th</sup> Street (a.k.a. Korvola Road)
10. County Road No. 1308 – S. W. Kirk Avenue Extension
11. County Road No. 981 – N. E. 35<sup>th</sup> Street (a.k.a. Riverside School Road)

WHEREAS the Department of Public Works has recommended that the Board of Commissioners transfer the roads to the City as outlined in the agreement, and

WHEREAS persons interested or concerned about this proposed transfer may examine any documents concerning this proposed action by contacting the Umatilla County Department of Public Works, 3920 Westgate, Pendleton, Oregon 97801, phone (541)278-5424, Monday through Friday, 8:00 a.m. to 5:00 p.m.

NOW THEREFORE IT IS ORDERED as follows:

1. A hearing is set for December 3, 2014, at 9:45 a.m. in Room 130 of the Umatilla County Courthouse, 216 S.E. Fourth Street, Pendleton, Oregon, to hear public testimony both for and against the proposed transfer and determine if the above described roads shall be transferred.
2. In accordance with ORS 373.270(2) (a), notice of the hearing shall be posted in at least 3 public places in the County, one of which shall be within the limits of the City.


