ORDER VACATING PORTION OF ROADS

WHEREAS, by resolution the Board of Commissioners for Umatilla County resolved that proceedings be undertaken to vacate the portions of County Roads #257, 342, 439 and 592 described in Exhibit "A" attached hereto and which by this reference is incorporated herein.

WHEREAS, the County Roadmaster was directed to examine the above described portions of the roads to be vacated and make a report on the roads, by order of the Board of Commissioners,

WHEREAS, a public hearing on the above described portion of the road to be vacated was set for October 1, 1980, at 10:00 a.m., in Room 114 of the Umatilla County Courthouse,

WHEREAS, notice of the hearing was given at least 30 days before the hearing pursuant to ORS 368.575,

WHEREAS, proof that notice was given was made by affidavit of the County Roadmaster and filed with the County Clerk,

WHEREAS, on October 1, 1980, a public hearing was held on the report of the County Roadmaster.

WHEREAS, the Board of County Commissioners finds that the above described portions of County Road #257, 342, 439 and 592 burdensome to maintain, and are not needed as a part of the County Road System and further, that the public will be benefited by the vacation,

NOW, THEREFORE, IT IS ORDERED that the above described portions of County Roads 257, 342, 439 and 592 be vacated.
