have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land thirty feet wide on the North side of the center line of County Road No. 616 as laid out across the South side of the Southwest Quarter of the Northeast Quarter of Section 32, Township 4 North, Range 28 East, W.M. Said strip of land being more particularly described as follows; Beginning at the Center of Section 32, thence North, along the Quarter Section line, 30 feet, thence East parallel to the Quarter Section line, approximately 1320 feet to the 1/16 Section line, thence South 30 feet to the Southeast corner of the Southwest Quarter of the Northeast Quarter of Section 32, thence West approximately 1320 feet to the place of beginning. All in Township 4 North, Range 28 East, W.M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
