RESOLUTION

WHEREAS the county may under ORS 368.470 by resolution declare it's intent to locate, establish, alter, widen, straighten or change the direction of any road, and

WHEREAS it appears to the Board of County Commissioners that the alteration and relocation of a portion of County Road #980 is necessary and beneficial to the safe travel over said route, and

WHEREAS the Board of County Commissioners believes that the relocation of said county road at said location would be in the public interest, would accrue to the benefit of the county in general as well as to the residents in the vicinity and that the alteration of said county road would compliment the county road system, and

WHEREAS a hearing must be held before the Board of County Commissioners for this purpose.

IT IS THEREFORE RESOLVED THAT IT IS THE INTENTION OF THE BOARD OF COUNTY COMMISSIONERS to relocate the centerline of that portion of County Road #980, lying within Sections 35 and 36, Township 3 North, Range 28 East, W.M., from it's present location to the south line of Sections 35 and 36, Township 3 North, Range 28 East, W.M., said centerline more precisely described as follows:

Beginning at the SE corner of Section 36, Township 3 North, Range 28 East, W.M.; thence S 89° 57' 14" W along the south line of Sections 35 and 36, Township 3 North, Range 28 East, W.M., 5,973.9 feet; thence on a 20.8° curve left 107.2 feet; thence S 67° 37' 28" W 420.2 feet; thence on a 20.8° curve right 295.6 feet; thence N 50° 48' 30" W 112.1 feet; thence on a 20.8° curve left 188.4 feet; thence S 89° 57' 14" W along the south line of Section 35, Township 3 North, Range 28 East, W.M. 946.4 feet to the centerline of County Road #656.

The parcel of land to be acquired for right-of-way purposes for this relocated portion of County Road #980 lies thirty (30) feet on either side of the above described centerline.

BE IT FURTHER RESOLVED that true copies of this Resolution, properly certified to be such by the County Clerk, shall be posted by the Roadmaster or his assistants in three (3) places in the vicinity of the said proposed road; that one (1) copy be posted upon the bulletin board in the west corridor of the County Courthouse in Pendleton, Oregon, said County Courthouse being the place where the Board of County Commissioners meetings are held; that copies shall be mailed to the record owners of the land on which the county road is to be established; and that this Resolution be duly entered in the Commissioner's Journal; and that a hearing be held before the Board of County Commissioners in Room 114, Umatilla County Courthouse, Pendleton, Oregon, on Wednesday, the 15th day of January, 1975, at 10:00 a.m. o'clock, at which time objections and remonstrances will be heard.
