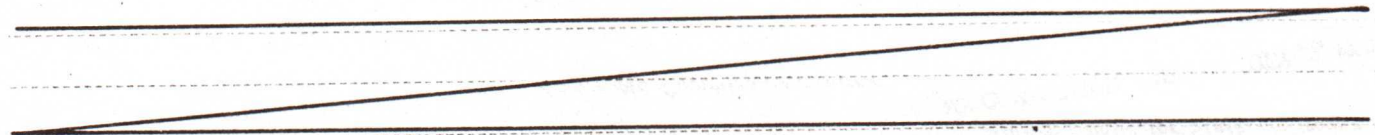

has granted, bargained, sold and conveyed, and by these presents does grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A tract of land in the Southwest Quarter of the Southwest Quarter of Section 2, Township 2 North, Range 30 East, W.M., more particularly described as follows: Beginning at a point 318.5 feet North and 42.9 feet East of the Section corner common to Sections 2, 3, 10 and 11, Township 2 North, Range 30 East, W.M., which point is on the west right of way line of County Road No. 265, thence North 27° 20' East, 24.4 feet, thence on a curve to the left of radius 190.4 feet, a distance of 134.1 feet, thence North 13° 02' West, 129.3 feet, thence South 76° 58' West, along the North bank of the Umatilla River, 66.0 feet, thence North 13° 02' West, 140.5 feet to a point on the South right of way line of the Old Oregon Trail Highway, thence North 82° 25' East, along the said right of way line, 96.0 feet, thence North 75° 09' East, along the said right of way line, 100.0 feet, thence South 75° 09' West, 0.0 feet, thence on a curve to the left of radius 72.3 feet, a distance of 111.3 feet, thence South 13° 02' East, 191.9 feet, thence on a curve to the right of radius 250.4 feet, a distance of 68.0 feet, to a point on the West right of way line of County Road No. 265, thence South 43° 25' West along said Westright of way line, 134.9 feet to the point of beginning.
