Now on this day this matter coming on to be heard upon the petition of the Pendleton Water Commission, praying this court that the privilege be granted said Company to erect construct and maintain a telephone line along the public road beginning at the NW corner of Sec. 10 Tp. 2 N.R. 34 E.W.M. being about 1/4 mile south of Cayuse station and ending at or near the property belonging to said company near Thorn Hollow station, and the court having duly considered said petition, it is HEREBY ORDERED that said petition be granted, said telephone line to be erected in such a manner as not to interfere with public travel.

Opening County Road No. 757

Now on this day this matter coming on regularly to be heard upon the report of the board of County Road viewers, heretofore instructed at the September 1913, term of this court, to view, survey, stake and report upon said proposed road No. 757 petitioned for as follows: Commencing in the County road at the Northeast corner of Section 17 Tp 3 N.R. 30 E.W.M. thence south on section line three miles to intersect the county road at the Northeast corner of section 32 Tp 3 N.R. 32 E.W.M. and to be 40 feet wide as a county road, for final hearing, the same having been publicly read the first time on October 1st, 1913, and publicly read the second time on October 2nd, 1913, and the said Board of County Road viewers, having reported favorably and recommended that said road be declared and established as a public highway of Umatilla County and it appearing to the court that said report is on file and certified to by the surveyor who surveyed the same and there being no objections or remonstrance on file against said report or the petition on file herein, and it appearing to the court that said road would be of sufficient public utility, it is,
THEREFORE HEREBY ORDERED, that said report of the Board of County Road viewers, be approved and that the same be recorded in the record of plats and field notes of Umatilla County, and that the road supervisor through whose district said road runs, be and he is hereby ordered to open said road for public use.

Now on this day this matter coming on regularly to be heard upon the report of the Board of County Road viewers heretofore instructed at the September 1913 term of this court to view survey and report on said proposed road No. 755, petitioned for as follows Commencing at southwest corner of section 18 Tp. 1 N.R. 32 E.W.M., running thence east along the section lines 18 & 17 to the Northeast corner of Northwest quarter of Section 20 Tp. 1 N.R. 32 E.W.M. and to be 40 feet wide, as a county road, for final hearing, the same name having been publicly read on two different days of the same term of court, to-wit: having been publicly read the first time of Oct. 1st 1913 and publicly read the second time on Oct. 2nd, 1913, and the said board of County Road Viewers, having reported favorably and recommended that said road be declared and established as a public highway of Umatilla County, and the plat and field notes being on file and Certified by the surveyor who surveyed the same, and there being no remonstrance or objections on file against said report or petition filed herein, and the court being satisfied that said road would be of sufficient public utility, it is
HEREBY ORDERED, that said report of the board of county road viewers, be approved and that plat and field notes be recorded in the record of plats and field notes of Umatilla County and that the road supervisor through whose district said road runs be and he is hereby ordered to open said road for public use.
