Now on thisday this matter coming on to be heard upon the report of the board of county road viewers, heretofore instructed at the May 1907 term of this court, to view, survey and report upon said proposed road No. 632, as follows: Commencing at the South East corner of the north east quarter of section 13, in Township 1 South Range 30-1/2 E. W. M.; thence North 73 deg East 488 ft.; thence north 59 deg East 847 feet; thence north 45 deg East 1129 feet; thence North 49 degrees East 1125 feet; thence North 41 deg East 1691 Feet to a post set in the ground, marked 1 Mile post; thence North 41 deg East 255 feet; thence North 44 deg East 1954 feet to the North East corner of the South East Quarter of Section 7, in Tp 1 South Range 31 EWM.; thence East through the center of section 8, Tp 1 South, Range 31 EWM. 3071 feet to a post set in the ground marked 2 Mile post; thence East 315 feet; thence North 66 deg 30' East 1357 feet; thence North 56 deg East 1738 feet; thence North 44 deg East 1435 feet; thence North 31 deg 15' East 435 feet to a post set in the ground makred 3 Mile post; thence North 21 deg 15' East 2447 feet; thence to the center of section 4 Tp. 1 South Range 31 EWM. thence North to the North West corner of North East Quarter of Section 4, Tp 1 South, Range 31 EWM. at base line; thence East to South West corner of South East Quarter 287 feet in section

33, in Tp 1 North, Range 31, EWM. to a post set in the ground marked 4 Mile post; thence North 19 deg 30' East 2800 feet; thence East 1023 feet; thence 48 deg East 1050 feet; thence North 42 ft to a post set in the ground marked 5 Mile post; thence North 1493 feet to the South West corner of Section 27, Tp 1 North Range 31 EWM; thence East 2587 feet along said South line of Section 27, Tp 1 North Range 31 EWM.; thence North 45 deg East 45ft. Thence East 1165 feet to a post set in the ground, marked 6 mile post; thence East 250 feet; thence North 70deg East 635 feet; thence North 84 deg East 645 Feet; thence along the section line between sections 26 and 27 in Tp 1 North Range 31 EWM. 2690 feet; thence North 51 deg 15 ' East 852 Feet; thence North 62 deg 12' east 208 feet; to a post set in the ground marked 7 Mile post; thence North 51 deg East 475 feet; thence North 58 deg 5 ' East 325 Feet; thence North 88 deg East 1183 feet; thence North 41 deg 45' East 1795 feet; thence North 87 deg 20 ' East 1395 feet to the South West corner of Section 24, in Tp 1 North Range 31 EWM.; thence East to the South East corner of the South West Quarter of Section 24, Township 1 North Range 31 EWM; thence North to the center of section 24, Tp 1 North Range 31 EWM.; thence East to the Township line to the South East corner of the North East quarter of Section 24, Tp 1 North, Range 31 EWM; thence North along the Township line between sections 19 and 24 and sections 13 and 18, a distance of 7438 feet to a point on said Township line; thence North 86 deg East 520 feet; thence North 23 Deg East 495 Feet; thence East 1157 feet to a point post set in the ground marked 11 Mile post; thence East 1137 feet to the South East Corner of South West quarter of section 7, in Tp 1 North Range 32 EWM.; thence East to the South East corner of section 7, in Tp 1 North Range 32 EWM.; thence North to the North East corner of Section 7, in Tp 1 North Range 32 EWM.; thence East to the South East corner of South West quarter of section 5, in Tp 1 North Range 32 EWM; thence North 6 deg East 520 feet; thence North 38 deg East 285 feet; thence 77 deg East 1990 feet; thence North 67 deg East 363 feet; thence North 42 Deg East 355 ft to a post set in the ground of the East line of the South East quarter of Section

5, Township 1 North Range 32 EWM intersecting a county road, as a county road for final hearing, the same having been publicly read on two different days of the same term of court, to-wit: Having been publicly read the 1st time on June 5th 1907 and publicly read the 2nd time on June 11, 1907. And the plat and field notes being on file and certified to by the surveyor appointed to survey the same, and the said board of county road Viewers, having reported favorably and recommended the establishing of said road as a county road, and the Court having viewed the location of said road, and being satisfied that said road would be of sufficient public utility, it is hereby ORDERED that said report of the board of county road viewers be accepted, and that said road be declared a county road in accordance with said report, except that where said road is surveyed through the lands of E. C. Wood, through the South East quarter of Section 27, Township 1 North, Range 31 EWM.; said road shall be established on the section line, and further that said road as is surveyed through the North West quarter of Section 26, Township 1 North Range 31 being through the land of Bain Bros. be changed from said survey as follows: From angle post No. 25 North 51 degrees East 1865 chains to angle post No. 29; said change in the construction of said road being made in such a manner that said road will run North West of the Well of Bain Bros. And the road supervisor through whose district said road runs, be and he is hereby ordered and instructed to open said road in accordance with this report and with this order. And that the plat and field notes be recorded in the record of Plats and Field Notes of Umatilla County.
