Known as the EAST BIRCH CREEK Highway

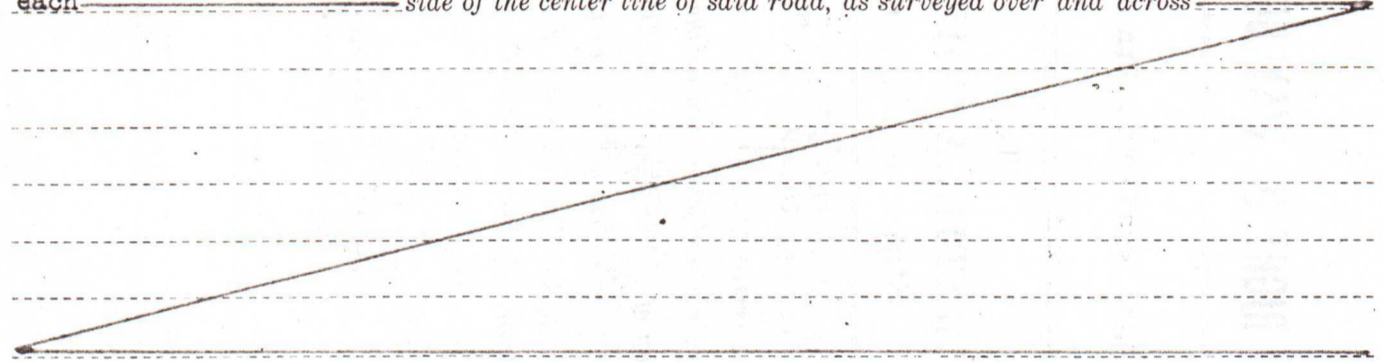
Know all men by these presents, That Muriel Ferringer Dolph and John M. Dolph, her husband

in the State of Oregon, in consideration of the benefits and other valuable considerations, and the sum of One Dollar

paid them, the receipt whereof is hereby acknowledged,

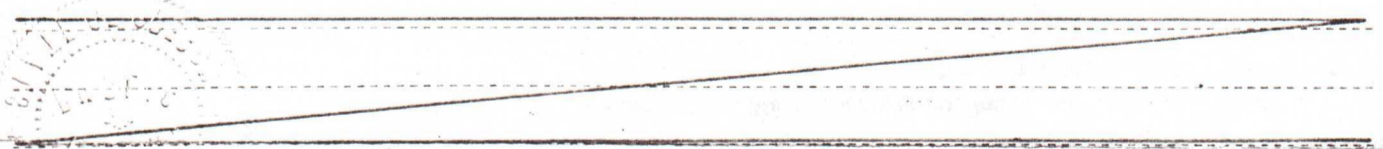
have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, in the State of Oregon, to-wit: A strip of land Sixty (60) feet wide, being Thirty (30) feet on each side of the center line of said road, as surveyed over and across



Section 28 and the North half of Section 33 Township 1 South Range 32 East W. M. Beginning at Station 87 / 20 of the East Birch Creek Highway Survey which Station is approximately 199 feet East and feet of the Section Corner which is common to Sections 20-21-28 and 29 Township 1 South Range 32 East W. M.

Thence South 16° 44' East, 975.4 Feet, thence on a 2° curve to the left 591.7 Feet, thence South 4° 54' East, 3456.0 Feet, thence on a 2° curve to the left 622.0 Feet to Station 143 / 65 of the said survey, which Station is approximately 400 Feet South and 900 Feet East of the Section Corner common to Sections 28-29-32 and 33, Township 1 South, Range 32 East W. M.

To have and to hold the same, unto the County of Umatilla, State of Oregon, for the purpose of a public road forever.
