In the matter of Vacating a portion of Road #147, beginning at a point in said road where the same crosses the Sec. line bet. Secs. 16 and 21, in Tp 2, N.R. 32, E.W.M. in Umatilla County, Oregon. } Road No. 147 } Docket #140.

Now on this day comes the report of the viewers J. M. Coffey, Thomas Jaques and R. Albee heretofore appointed at the September 1896, term of this Court to view out and report upon the advisability and necessity of vacating that portion of County Road No. 147, described as follows:

Beginning at a point in said road where the same crosses the Section line between Sections 16 and 21, in Township 2 North Range 32 East Willamette Meridian, in Umatilla County, Oregon; thence in a Southwesterly direction along said road across said Section 21; thence in a Southeastly direction along said road, across Sections 28 and 33, in said Township and Range, to a point on said road near the Southeast corner of said Section 33, where said road is now intersected on the ridge by the road now leading up from Lee's Crossing, on Birch Creek, in Section 4 Township 1 North Range 32 aforesaid. Said Road No. 147 being known as the Road from Pendleton to Stephill's, platted and recorded at page 329 of Book "A" of the Records of Roads of said Umatilla County. And the matter at this time coming up for final hearing, the same having been read upon a previous day of this term of this Court, to-wit: The Nov. term, 1896 of this Court, and the said viewers having reported favorably and recommend the establishing of the same as a County Road and the field notes and plat of survey being duly on file and certified to by the Surveyor appointed to survey the same, and there being no remonstrance or claim for damages on file against said road, and all matters in regard to the vacation thereof having been fully complied with according
