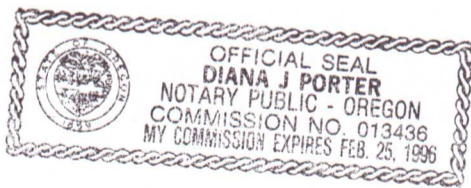

EO-2190 PUBLIC NOTICE BEFORE THE BOARD OF COUNTY COMMISSIONERS FOR UMATILLA COUNTY, OREGON

IN THE MATTER OF THE TRANSFERRING OF JURISDICTION OF A PORTION OF COUNTY ROAD 1303 TO THE CITY OF PENDLETON, OREGON, AND A PORTION OF COUNTY ROAD 1386 TO THE CITY OF PILOT ROCK, OREGON

Notice is hereby given that the Umatilla County Board of Commissioners intends to hold a hearing to consider the transfer of jurisdiction of the following roads to the Cities of Pendleton, Oregon and Pilot Rock, Oregon:

- 1) Circle Road (No. 1386) from the intersection of County Roads 1386 and 1388 to the east 1/4 corner of Section 8, Township 1 South, Range 32 E.W.M. to the City of Pilot Rock, Umatilla County, Oregon,

- and 2) Southgate Place (NO. 1303) from the westerly right-of-way line of U. S. Highway 395 to old Oregon State Highway centerline station 140+49.77 on the road formerly known as Montee Drive to the City of Pendleton, Umatilla County, Oregon.

The preliminary assessment by the Director of Public Works is that it would best serve the public by transferring the jurisdiction of these roads to the Cities named.

The Umatilla County Board of Commissioners, under authority of ORS 373.270 intends to hold a public hearing on the transfer of jurisdiction of these roads on April 19, 1995, at 10:15 a.m. in Room 114 of the Umatilla County Courthouse, Pendleton, Oregon. Any persons wishing to be heard on this subject may attend this hearing and present appropriate information for consideration by the Board of Commissioners, who subsequently will determine whether the offers of jurisdiction transfer shall be made to the mentioned cities.
