have granted, bargained, sold and conveyed, and by these presents do grant, bargain, sell and convey unto the County of Umatilla, State of Oregon, the following described parcel of land, situate in Umatilla County, State of Oregon, to-wit: A strip of land 60 feet wide, being 30 feet wide on each side of the center line described as follows: beginning at a point which point is 364 feet north of the southwest corner of the SE<sup>1</sup> of SE<sup>1</sup> of Section 8, Township 1 South, Range 32, E.W.M.: thence along a tangent with a bearing of S 47° 30' West for a distance of 213.2 feet: thence around a 24° curve right with a central angle of 76° 37' Right for a distance of 319.2 feet: thence along a tangent with a bearing of N 55° 53' West for a distance of 399.9 feet: thence around a 36° curve left with a central angle of 112° 25' left for a distance of 312.2 feet: thence along a tangent with a bearing of S 11° 42' West for a distance of 141.4 feet: thence around a 20° 6' curve right with a central angle of 79° 43' Right for a distance of 398.6 feet to a point in the center of the present County Road, said point being 1254 feet west of the point of beginning.
