R E S O L U T I O N

WHEREAS Ron Reeser, Pilot Rock, has requested the Umatilla County Board of Commissioners to Relocate a portion of County Road #672, and

WHEREAS the portion to be Relocated has the following description:

A portion of County Road #672 being 60 foot wide and lying 30 feet on either side of the following described centerline as situated in the SE 1/4 of Section 8, Township 1 South, Range 32 E., W.M.

Commencing at the SE corner of said Section 8, Thence N 89° 46' 10" W, along the South line of said Section 8, 2,520.37 feet to the point of beginning for this description, Thence on a 225.10 foot radius curve to the left, (Long chord bears N 74° 39' 02" E, 192.69 feet) an arc distance of 195.07 feet, Thence N 59° 06' 35" E, 471.75 feet, Thence on a 210.72 foot radius curve right (Long chord bears S 89° 13' 08" E, 221.28 feet) an arc distance of 232.96 feet to the termination point.

Said parcel containing 1.22 acres.

WHEREAS the Relocated right-of-way will be described as follows:

A portion of Umatilla County Road #672 being 60 feet wide and lying 30 feet on either side of the following described centerline as situated in the SE 1/4 of Section 8, Township 1 South, Range 32 E., W.M.

Commencing at the SE corner of said Section 8, Thence N 89° 46' 10" W, along the South line of said Section 8, 2,520.37 feet to the point of beginning for this description, Thence on a 225.10 foot radius curve to the left (Long chord bears N 49° 53' 15" E, 291.21 feet) an arc distance of 316.69 feet, Thence N 09° 35' 00" E, 157.06 feet, Thence on a 185.79 foot radius curve right (Long chord bears N 66° 01' 05" E, 309.62 feet) an arc distance of 366.00 feet, Thence S 57° 32' 50" E, 332.00 feet

to the termination point.

Said parcel contains 1.6 acres.

WHEREAS the interest of the traveling public will not be hindered by the requested Relocation, now therefore

BE IT RESOLVED that true copies of the Resolution, properly certified to be such by the County Clerk, shall be posted by the Roadmaster or his assistants in three (3) places in the vicinity of the said proposed road; that one (1) copy be posted upon the bulletin board in the West corridor of the County Courthouse in Pendleton, Oregon, said County Courthouse being the place where the Board of County Commissioner's meetings are held; that copies shall be mailed to the record owners of the land on which the county road is to be established; and that this Resolution be duly entered in the Commissioners' Journal; and that a Hearing be held before the Board of County Commissioners in Room 114 of the Umatilla County Courthouse, Pendleton, Oregon, on Wednesday, the 15th day of September, 1976, at 10:30 o'clock, at which time objections and remonstrances will be heard.
