

In County Court September term 1884  
9<sup>th</sup> Judicial day Wednesday Sept 10<sup>th</sup> 1884

In the matter of County Road commencing  
at the Co Road opposite the mouth of a  
Canyon in the Vinson Canyon about 1/2 mile  
E. of the town of Vinson, thence in a Northerly  
direction along <sup>and</sup> up said Canyon to the line  
running E <sup>and</sup> W. between Secs 14 & 15 T<sup>1</sup> S. R.  
30 E. thence E. along said line to the N. E. Cor.  
Sec 13 in said T<sup>1</sup> & R. thence South 1/2 mile  
on line between Rgs 30 & 30 1/2, thence E. to the  
intersection of County Road running from  
Rees Crossing on Birch Creek to Vinson.

Now on this day comes the report  
of the viewers heretofore appointed at the July term 1884 of this Court to view  
out <sup>and</sup> report upon the location of the above mentioned road as a County  
Road for final hearing. The same having been read upon a previous day  
of this term of this Court, to-wit: September term 1884. <sup>and</sup> the said viewers  
having reported favorably <sup>and</sup> recommending the establishing of the same  
as a County Road, <sup>and</sup> the field notes <sup>and</sup> plat of survey being duly on file  
<sup>and</sup> certified to by the surveyor appointed to survey the same, <sup>and</sup> there  
being no remonstrance on file against said road.

It is therefore ordered by the Court that said road be established  
as a County Road in accordance with the report of said viewers, <sup>and</sup>  
that the report of said viewers, field notes <sup>and</sup> plat of survey thereof, be re-  
corded as by law required, <sup>and</sup> that the supervisors through whose District  
said road runs, open the same for public use.
