WHEREAS, an order dated October 12<sup>th</sup>, 1962, vacating County Road No. 338 was found to be in error because the legal description of the vacation also included a portion of old Road #381, and

WHEREAS, it is clear that the intent was to vacate the road described in the legal description and not the road described by road numbers:

IT IS HEREBY ORDERED that the description on the order vacating County Road No. 338 which is recorded in the County Court Journals, Volume "W", Pages 239-240 and is attached hereto and incorporated herein as Attachment "A", Pages 1-3, be Amended to read as follows:

Beginning at a point in the center of County Road No. 338, said point being the NE Corner of the SE ¼ of the SE ¼ of Section 21, T. 5 S., R. 32 E.W.M. and 1320 feet North of the Section Corner common to Sections 21, 22, 27, and 28, T. 5 S., R. 32 E.W.M.; thence south along the Section Line and County Road No. 338 centerline approximately ¼ mile to the Section Corner Common to Sections 21, 22, 27, and 28 and its intersection with County Road No. 381; thence South along the Section line between Sections 27 and 28 and the centerline of County Road No. 381 approximately ½ mile to the ¼ corner common to Sections 27 and 28; thence Southwesterly along the centerline of County Road No. 381 approximately 1056 feet to its intersection with County Road No. 502 and there terminating.

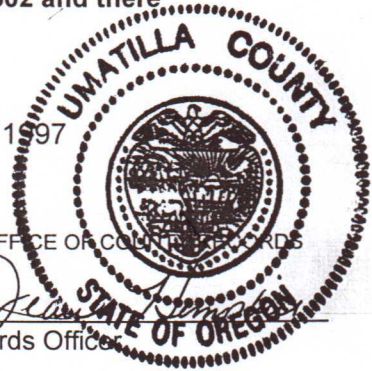

ORDER VACATING COUNTY ROAD  
NO. 338

NOW ON THIS DAY THIS MATTER coming on now to be heard, this being the time and place set by the Court for hearing upon this matter; and it appearing to the Court that due and lawful advertisement of the Final Hearing has been given by posting of three true copies of the Notice of Hearing on file herein at three public places in the vicinity of said road and at one public place of said County where public notices are usually posted and as shown by the Affidavit of Posting Notices on file herein; that each of said Notices remained so posted for more than 30 days thereafter; and it appearing that due proof of the posting of said Notices is now before the Court and it appearing that no objections have been made or filed to such proposed vacation, and it further appearing that said portion of said road so proposed to be vacated is not useful as a part of the general road system of Umatilla County, Oregon, and that the public will be benefited by the vacation thereof, and it further appearing that said road is not now used.

IT IS THEREFORE, ORDERED, ADJUDGED, AND DECREED that the following described portion of said road be vacated.

Beginning at a point on NE corner of SE $\frac{1}{4}$  of SE $\frac{1}{4}$  of Sec. 21 said point of beginning being 1320 ft N. of Sec. Cor. common to Sec. 21, 22, 27, and 28, running thence S. on Sec. line between Sec. 21, 22, 27, and 28 a distance of about 3/4 miles to the  $\frac{1}{4}$  cor. between Sec. 27 and 28, thence running Southwesterly direction 1056 ft to a junction of Road 338, 502 and 381.

for the reason that said portion of said road is useless and burdensome, is of no value either to individuals or to the general public; that the same is useless as a part of the general road system of Umatilla County, Oregon, and that the public will be benefited by the vacation of the same.
