A strip of ground for Highway purposes 60 feet wide over and across the NW 1/4 of the NE 1/4 of Section 12 Township 5 S.R. 33 E.W.M. the center line being more particularly described as: Beginning at a point 1194.5 feet South of and 1157.6 feet East of the N.W. corner of the NE 1/4 of Section 12, Township 5 S.R.33 E.W.M., thence N. 25° 18.5' W. a distance of 1326.1 feet to a point on the East and West Section line between Sections 1 and 12, said point bearing N. 89° 35' W. and 590.7 feet distant from the NW corner of the NE 1/4 of Section 12 Township 5 S. R. 33 E.W.M. and containing 1.8 Acres.
