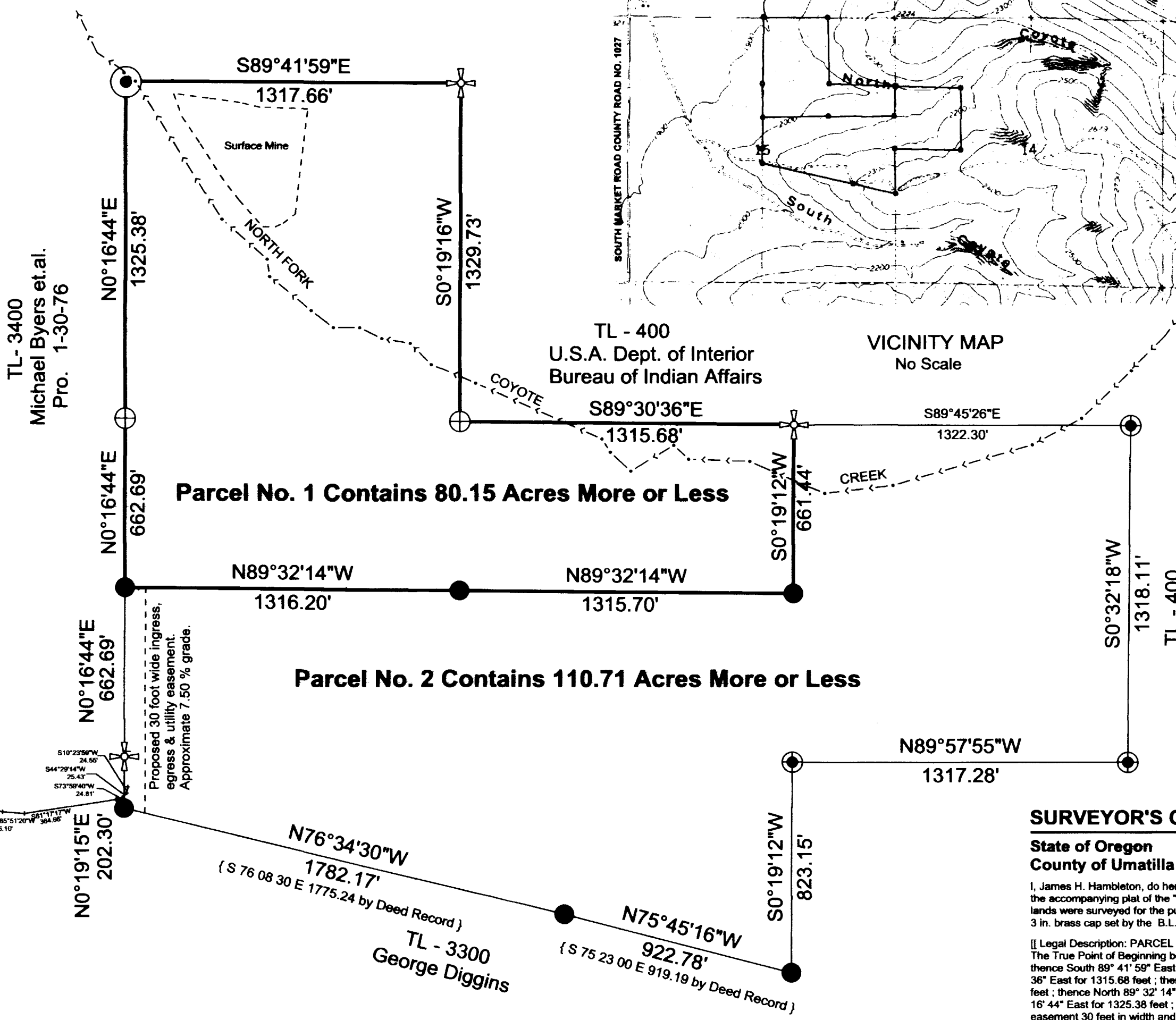


# FINAL PARTITION PLAT McCORMMACH RANCHES PARTITION

### SURVEYOR'S CERTIFICATE

I, James H. Hambleton, do hereby certify that I used a Topcon GTS-3B total station to survey and marked with proper monuments, as indicated on the accompanying plat of the "McCORMMACH RANCHES PARTITION" situated in Section 15, T 1 N, R 33 E W.M, Umatilla County Oregon. The lands were surveyed for a parcel of land of which is intended to be a surface mine. The initial point of this survey is a 3 in. brass cap set by the B.L.M. for the 1/4 corner common to Sections 10 & 15, T 1 N, R 33 E W.M. Survey was completed Feb. 20, 2003.

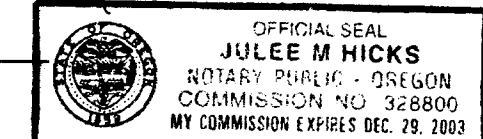

The Historical Easement 20 feet wide and created by an Easement Deed, dated August 5, 1942 and being recorded in the Umatilla County Deed Record Book No. 164, Page 545 is too vague to physically locate on the ground by survey. Therefore using the evidence of present day use and topographic maps, I located the center line near to what the original intent might have been.

NOTE :  
Proposed easement maintenance responsibilities are the owners of parcel No.1.  
Future Source of Water Supply would be by well and pump.
