Frank a bachelor being the owner of a Railroad Addition to the City of Freewater, State of Oregon, do hereby for the use of the public, dedicate the streets and alleys as shown on this plat, reserving to myself, my heirs and assigns, all of the water and privileges, to the streams flowing through said addition, with the right to lay underground conduits of any kind along or across, any of said streets as shown herein; and also reserving for myself and my assigns, the right to erect and maintain electric light, power, telegraph and telephone poles, and the right of way for an electric railway along or across any of said streets.
