# STANFIELD ORCHARD OUTLOTS.

LOCATED ON THE SO 1/2 OF SEC. 32, T. 4 N., R. 29 E. Y.M.  
AT STANFIELD, UMATILLA COUNTY OREGON.

I, Deane B. Spalding, BEING FIRST DULY SWORN, ON OATH SAY, THAT I AM THE SURVEYOR, WHO SURVEYED THE STANFIELD ORCHARD OUTLOTS, THAT I HAVE CORRECTLY SURVEYED AND MARKED WITH PROPER MONUMENTS LANDS REPRESENTED UPON THIS PLAT THERE OF, THAT I HAVE CAUSED TO BE PLACED A PROPER MONUMENT, BEING GALVANIZED IRON PIPE TWO INCHES IN DIAMETER AND THREE FEET LONG, AT THE INITIAL POINT OF SUCH SURVEY, THE TOP THEREOF BEING SIX INCHES BELOW THE SURFACE OF THE GROUND, WHICH INITIAL POINT IS 844 FEET DUE EAST OF THE NORTHEAST CORNER OF THE SOUTH WEST QUARTER OF THE SOUTH WEST QUARTER OF SECTION 32, TOWNSHIP 4 NORTH, RANGE 29 EAST OF THE WILLAMETTE MERIDIAN AND IS LOCATED WHERE THE EAST LINE OF WAYNE STREET, AS SHOWN ON THE PLAT OF COE'S FIRST ADDITION TO THE TOWN OF STANFIELD, INTERSECTS THE CENTER LINE OF COE AVENUE AS SHOWN ON THE ATTACHED PLAT, AND THAT THE LANDS INCLUDED WITHIN THE ATTACHED PLAT ARE LOCATED IN THE SOUTH HALF OF SECTION 32, TOWNSHIP 4 NORTH, RANGE 29 EAST OF THE WILLAMETTE MERIDIAN IN UMATILLA COUNTY OREGON.
