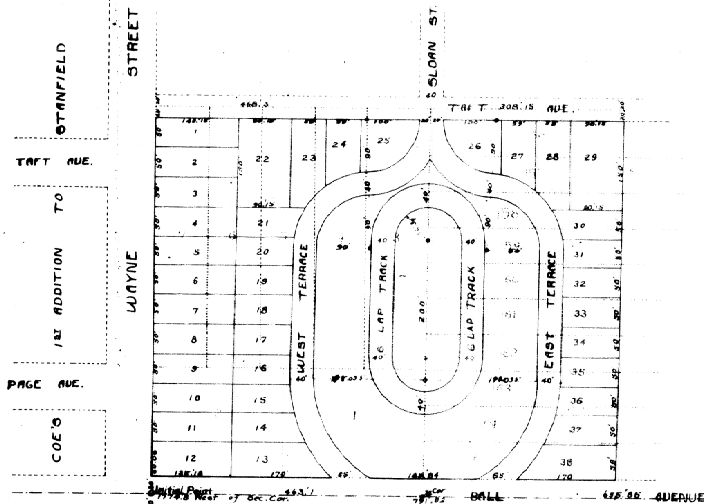


PLAT OF

AFFIDAVIT OF SURVEY

C. D. Porter being duly sworn, upon oath says, that he is the Surveyor who surveyed the Olympic Park Subdivision of Stanfield Orchard Out-Lots Nos. 1 to 7 and 156 to 165 and same is correctly marked on the ground by proper stakes and monuments as represented upon the annexed Plat of said Subdivision; that at the Initial Point of this survey he established a proper monument, the same being a galvanized iron pipe two inches in diameter and three feet long and driven in the ground so that top end thereof is six inches below the surface of the ground, which Initial Point and Monument is located on the South line of Sec. 32 T. 4 N. R. 29 E. W.M., at its intersection with the East line of Wayne Street in Coe's First Addition to the Town of Stanfield and 1776.8 feet West of the Southeast corner of said Section, and that all dimensions of said subdivision are marked on said plat in feet and decimal parts of a foot, and said land included in said plat are a part of the Southeast quarter of said Section 32, in Umatilla County, Oregon.
